I wish to submit this input to the Puget Sound Partnership - Near term Action Plan/Strategy 1/19/12 Dr. Karl Spees PSP - Puget Sound Partnership 1/1/12 The citizens are getting weary of the Big Gov. power grab redistribution schemes of the current regime. PSP, Puget Sound Partnership is just the latest iteration in this blitz. It is fairly stereotypical of these big gov. scams. Identify/create an artificial crisis implying a need for urgent governmental intervention. Gin up data or "new-science" that may or may not be accurate or present known data/science in ways that distorts perceptions to justify some action. Assign false blame to justify some predetermined regulatory objective. Use the gov. supporting media to blackout the obvious arguments against such scams and flood the media with scare baiters hype, hysteria, and hyperbole /propaganda. Then divert scarce resources from necessary government functions like public safety to fund these utopian scams. Institute regulatory controls transferring power from the legitimate holders into the hands of big central gov. or central government agencies. Think of the grand scam of Man Made Global Warming. Think the war on affordable energy and portrayal of CO2 as a pollutant, as opposed to an absolutely essential atmospheric gas. Think East Anglia University as a prototype for much of this scheming monumental malfeasance. Think of the DoE (Ecology) as being the surrogate of Christine Gregoire and PSP the surrogate of the Democrat Party.

(They come from Thailand, China, Alaska, etc.) It also ignores the reality that Victoria and other Canadian municipalities discharge tons of raw sewage into the Straits of Juan de Fuca and the Salish Seas on a daily basis. One needs to suspend reality or be brain dead or a two-time Obama voter to buy into this voodoo grandiose utopian schemes. These charlatans base actions on a computer models and juggle the parameters until they get the desired outcome. They base policies on isolated data that have no or little relevance in reality. They make it convoluted enough that only the upper echelons understand it's a scam. The chronically gullible and duped are guilted, seduced, bribed, cumbaya-ed, or grouped into mass hysteria-like responses. They have party committee chairmen delving out piles of "free money" to the party faithful (diversion of funds) in the form of grants. Some of these destructive self-serving programs will be implemented. Put out overwhelming amounts of data or work documents that are difficult at best to decipher. Bury data or encode data that clearly shows a lack of relevance of this self-serving agenda. Another technique is only release conclusions but no data. Again the objective is not to fix "the problem" but redistribute wealth into the hands of the Party Faithful (parasites) and promote the perpetuation of the dysfunctional ruling bureaucrats (the governmental parasites). Another problem with some of the PSP recommendation is that they impose the solutions to recognized city/urban problems on the suburban and rural populations. Some of these policies may indeed have merit for cities but maladaptive for less densely settled areas.
